Sam is preparing for work placement with children aged 0-5 years. She has been asked to choose types of provision where she will spend time working with children.

When working with children it is important to recognise the responsibilities of our own role. Sam will need to understand when she should pass on information to other professionals at the work setting.

It is important to value each individual person with respect. Sam will need to know how to respond to the individual needs of children whilst on her work placement.

- Their location (you could use a map)
- Opening times or session times
- Cost
- The services offered

The last bit should be the biggest part. Give full information about what happens at the service (childcare/education) and the types of things that the children do at the service.

- Whether the setting is statutory/private/voluntary and why.
- The purpose of this type of setting explaining **why** it is useful for children and parents.
- **Explain** the activities available at the setting and **how** these may help the children build certain types of skills.
- If parents have to pay to use the service **explain why you** think parents would choose to pay to use this service.
- What parents does it support/help? Working parents? Low income parents? And why/how.
